Legislative Update

Executive Director Adams reported on the following legislative bills filed during the 2018 Legislative Session:

HB 187 – This bill passed and will require dyslexia training in teacher preparation programs. Staff will work with institutions to have this requirement incorporated beginning in 2019.

HB 319- This bill passed and will require the EPSB to process out-of-state applications for applicants who apply for the same licensure area in Kentucky as the state in which they are currently licensed within 30 days of a completed application. Mr. Adams noted that not all teaching certificates in other states have the same level of standard as Kentucky so this may present an issue in the future.

HB 586- This bill passed and will allow the extension of time for an individual to complete Rank II requirements if called to active duty or required military training. This requirement is close to the agency's current practice, just now statutorily required.

HB 200- This is the budget bill. It provides funding for the EPSB, but does not fund the Kentucky Teacher Internship Program or Kentucky Principal Internship Program. Staff may recommend the suspension of these programs if no funding is received by the end of the legislative session.

SB 257- This bill did not move out of committee. It was the bill to reorganize the EPSB.

HB 108 – The original language of this bill was removed and replaced with the language in SB 257. This bill keeps the EPSB as an independent Board; however, it eliminates the agency, transfers all personnel, records, files, equipment and funds to KDE, and gives the Executive Director responsibilities to the Commissioner of Education.

HB 74 – This bill did not move out of committee. It removed the Rank II requirement.

Executive Director Adams said staff met with the legislature regarding the joint resolution to suspend the Rank II requirement. It did not move. He recommended that the Board consider at the June or August meeting whether to continue with the Rank II requirement, because proposed legislation will likely continue in future legislative sessions.

Charter and Appointments for the School Counselor Review Committee

Ms. Sherri Henley explained that in January 2005, the EPSB adopted the Kentucky Standards for Guidance Counseling Programs and amended 16 KAR 3:060 to reflect these new standards. These standards have served as the foundation for the school counselor preparation programs for the past 13 years. The revision of these standards is necessary to identify standards that align with the professional responsibilities of Kentucky P-12 school counselors. The purpose of the Charter and School Counselor Standards Review Committee is to review the current School Counselor Standards and make recommendations to update and revise.

Chair Akers asked if the current practice in which some counselors perform administrative duties is expected to change. Commissioner Pruitt said his intent is to make many radical changes on the expectations of school counselors, including them not serving as building assessment

Director of Pupil Personnel (Level I and Level II)

Background:

The proposed Director of Pupil Personnel (DPP) program at Northern Kentucky University (NKU) was designed in collaboration with an advisory council, school principals, and superintendents representing local school districts. Program designers also collaborated with NKU professors in Social Work and Special Education to offer courses in areas such as drug dependency, trauma focused care, bullying, cyber bullying, special needs and child abuse that are course options within the Level II program.

Prerequisites for admission include a master's degree, 3.0 GPA, professional teaching certification showing Rank II or Rank I and Level I and Level II principal certification, and a minimum of three years teaching experience. Courses will be delivered online and include fieldwork with certified DPPs. Level I and Level II require six (6) hours of coursework for each

Agenda Book

level. Level I coursework addresses topics such as responsibilities of administrators, school-year planning, creating and monitoring school budgets, responsibilities with parents and students, legalities relating to attendance and juveniles, development and implementation of attendance and dropout prevention, and district pupil personnel services. Level II coursework includes options in school administration, school finance and budgeting, students with exceptionalities, families of students with disabilities, and various topics within the field of social work (i.e., juvenile suicide, bullying, and child abuse). To exit the program, candidates complete all coursework with a minimum 3.0 GPA, demonstrate satisfactory performance on the PSEL standards, and sign the code of ethics.

KRS 161.028 and KRS 161.030 provide for the EPSB to establish curricula for educator preparation programs in Kentucky and approve such programs for Educator Preparation Providers. The Division of Educator Preparation, Assessment, and Internship, Content Reviewers, and the Program Review Committee evaluated the program review documents submitted for approval against performance-based program guidelines established by the EPSB. These program proposals meet all the requirements set forth by the EPSB. A Letter of Support from the Dean of the College of Education and Human Services of Northern Kentucky University and the program review documents are available on the EPSB secure website.

Background:

KRS 161.028(1) states that the Education Professional Standards Board shall issue a Rank II to those holding regular certificates and who have a master's degree in a subject field approved by the Education Professional Standards Board or equivalent continuing education.

The Board appointed an Ad Hoc Committee to review expanding certificate options for Rank II. The committee first met on March 28, 2017, and again on April 25, 2017. The Rank II Options Committee is composed of stakeholders representing both public and private higher education, school district administrators and teachers. The purpose of the committee is to make recommendations to the Board on options that will be available to teachers earning a Rank II. While meeting, the committee was steadfast that any option must be equivalent in rigor to master's level work; relate directly to the current work of the educator; and be cost effective, paying dividends not just in compensation for the teacher, but for the students and their learning in the classroom.

Currently, there are three options for obtaining a Rank II. The first option is to complete a content master's degree program in the area of certification held. The second option is to complete an approved Fifth-year Program of thirty-two (32) semester hours of graduate level coursework earned beyond the bachelor's degree and the four (4) year program of teacher preparation. The third option is to complete the Continuing Education Option that is made up of a combination of research, job-embedded professional development, and university courses.

- Programs shall be aligned with the Council for the Accreditation of Educator Preparation (CAEP) Standards for Advanced Programs.
- Programs shall provide opportunities to enhance P-12 student achievement by directly focusing on the Kentucky Academic Standards and College and Career Readiness Standards.
- Programs shall follow the revised Teacher Leader Program Guidelines (August 2016).
- Programs shall reflect the Teacher Leader Model Standards.
- EPSB shall develop regulations that set forth the standards for the programs and develop an implementation plan.

In June 2017, the Board approved a regulation to establish the standards required for certified teachers to obtain or maintain certification as a teacher leader. The standards are aligned with both the InTASC Standards and the CAEP Standards for Advanced Programs. In April 2018, 16 KAR 1:016 became effective and established the standards for certified teacher leader. During

Background:

Beginning December 1, 2016, Kentucky became a member of the State Authorization Reciprocity Agreement (SARA). This agreement among member states, districts and territories establishes comparable national standards for interstate offering of postsecondary distance education courses and programs. It is intended to make it easier for students to take online courses offered by postsecondary institutions based in another state. SARA is overseen by a National Council and administered by four regional education compacts (i.e, SREB). In order for the EPSB to approve educator preparation programs, which are located in SARA member states and are exclusively offered online, the educator preparation program has to demonstrate compliance with the following Kentucky requirements:

1. Demonstrate that the program of preparation has been approved by the provider’s state or origin.
2. Demonstrate that the entity has been regionally accredited.
3. Demonstrate that the entity has been accredited by the Council for Accreditation of Educator Preparation (CAEP).

4. Demonstrate that the program of preparation is not based only upon the completion of a written or verbal assessment.
5. Demonstrate that the program of preparation has a selection and admission process that meets the requirements of 16 KAR 5:020.

Indiana Wesleyan University's (IWU) Master of Education with a major in Curriculum & Instruction (C&I) consists of an eleven-course, 33-credit hour program of wholly online study intended to help practicing teachers advance their craft in teaching and leadership in professional learning communities. It is considered an advanced preparation program, but does not lead to additional content licensure in Indiana based on the current licensure scheme in place. The program is currently aligned to the Teacher Leader Model standards. In recognition of the need to align its advanced preparation programs to the 2016 CAEP Advanced Program Standards and to utilize CAEP-sufficient rubrics, the curriculum of the IWU C&I program is in the early stages of a two-year curriculum redesign process that will include refined gateways and assessments.

The purpose of the Master of Education Program is to provide advanced study beyond the baccalaureate degree to meet the professional needs of practicing teachers. Outcomes and expectations associated with developing master teachers as World Changers are:

- Leading curricular change. Candidates are proficient in curriculum development and implementation; knowledge of curriculum and subject matter is used to create positive change in classrooms, schools, and districts.
- Implementing instructional effectiveness. Candidates are proficient in the knowledge, dispositions, and skills needed for effective teaching; effective teaching results in successful student learning.
- Managing classroom learning. Candidates manage the classroom learning environment to create success for all students.
- Practicing reflective assessment. Candidates manage their continued learning and professional development through continuous reflection about their teaching knowledge, dispositions, skills, and practices.
- Building learning networks. Candidates create professional partnerships to create learning opportunities for themselves and their students.

16 KAR 4:080 provides that an out-of-state educator who applied for and received a Kentucky teaching certificate must complete six hours of graduate credit in order to renew the applicant's Kentucky certificate:

Section 1. Teacher certification issued initially under the provisions of 16 KAR 2:010 or 16 KAR 2:020 shall comply with the provisions of KRS 161.030 and the requirements and procedures established in this section.

- (1) There shall be a recency of preparation prerequisite for the issuance of a certificate.
 - (a) Except as provided in paragraphs (b) and (c) of this subsection, an out-of-state applicant for initial Kentucky certification shall have prepared as a teacher or completed six (6) semester hours of graduate credit within the five (5) years preceding application.
 - (b) An out-of-state applicant for initial Kentucky certification who has completed a planned fifth-year program shall be exempt from taking the six (6) additional hours, if the applicant has completed two (2) years of successful teaching experience within the last ten (10) years.
 - (c)1. A certificate shall be issued for a one (1) year period ending June 30 of the next calendar year if the applicant:
 - a. Does not meet the recency of preparation requisite;
 - b. Has not previously held a Kentucky teaching certificate;
 - c. Otherwise qualifies for certification; and
 - d. Agrees that six (6) semester hours of credit applicable toward the usual renewal requirement shall be completed by September 1 of the year of expiration.

Brian Creasman, Fleming County Superintendent, submitted this request on behalf of Ms. Debra Howard who obtained a Kentucky certificate based on her Florida and Virginia certificates.

Issue:

Should the Education Professional Standards Board waive regulation 16 KAR 5:040, Section 6 (4) which requires educator preparation institutions to provide seventy (70) full days, or its equivalent, of student teaching?

Background:

District wide school closings in the Spring 2018 semester have forced school closings in schools where student teachers in Kentucky Educator Preparation Programs are assigned for their required 70 days of student teaching. Although student teachers and their respective programs have made good faith efforts to complete as many days as possible. (e.g., beginning student teaching earlier in the semester and ensuring the candidates student teach every day their assigned schools are open) some candidates' assigned schools will not be open a sufficient number of days for the candidates to complete 70 days of student teaching.

Kentucky's preparation programs are tied to their institutional calendars, which control operational matters such as contractual obligations of staff, availability of on-campus housing, dates by which credit must be awarded for students to be eligible to graduate, start dates of subsequent course offerings, and other similar challenges. Staff is asking the Board to waive 16 KAR 5:040, Section 6 (4) for the Spring 2018 semester as it applies to affected candidates enrolled in programs whose unit head have submitted waiver requests. Each waiver request is supported with documentation signed by the unit head indicating the name of each student teacher, the district and the number of days affected student teachers assigned to that district were unable to participate in student teaching due to district school closures. Universities requesting waivers are: University of Louisville; University of the Cumberland; University of Kentucky; Morehead State University; Murray State University; and Northern Kentucky University.
