"Disciplinary action" is defined as any termination, suspension, or public reprimand issued by any school district in the Commonwealth of Kentucky and upheld, if requested, by either a tribunal and/or arbitration process including any appeal therefrom. Craig has provided proof that he has taken extensive training on the subjects of Safe Crisis Management and classroom management.

From the date the Board approves this Order, Certificate 201189513 shall be under a two-year probation and subject to the following condition:

Craig shall not receive any disciplinary action related to classroom management from any school district in which he is employed. If Craig fails to satisfy this condition, Certificate Number 201189513 shall be administratively suspended pending Board review and disposition.

“Disciplinary action” is defined as any suspension, termination, or public reprimand issued by any school district in the Commonwealth of Kentucky and upheld, if requested, by either a tribunal and/or arbitration process, including any appeal therefrom.

#### **Consent Item:**

Request to Offer Programs at an Off-Site Location, Campbellsville University

#### **Staff Recommendation:**

The Education Professional Standards Board (EPSB) should approve Campbellsville University's request.

#### **Rationale:**

Campbellsville University has addressed the identified components of the applicable regulation in the request. These required components include the location and physical attributes, qualifications of faculty, and identified courses to be offered at the off-site location. Campbellsville University can provide the necessary resources, advisement and faculty to support the additional off-site location. Candidates will have full access to instructional and technological resources.

#### **Action Question:**

Should the EPSB approve the request to allow Campbellsville University to establish an off-site location for its principal program?

#### **Applicable Statute or Regulation:**

KRS 161.028, KRS 161.042, 16 KAR 5:010

#### **History/Background:**

*Existing Policy:* 16 KAR 5:010, Section 28, requires EPSB approval for off-site and online programs established by educator preparation providers. The institution must submit a written request to the EPSB describing the location and physical attributes of the off-campus site, resources to be provided, faculty and their qualifications and a list of courses or programs to be offered.

*Summary:* Campbellsville University is requesting approval for an off-site campus in Taylor County. The superintendent of Taylor County Schools has requested a collaborative agreement with Campbellsville University to offer its school principal preparation program as part of a Grow Your Own initiative. Coursework will be provided in both campus-based and online formats. Classes will be held at the Central Kentucky Career Center (CKCC) in Campbellsville. The CKCC is located approximately three miles from the main campus of Campbellsville University's School of Education. Technology is available in the facility for faculty use as needed. A typical classroom is approximately 754 sq. feet and is designated for didactic teaching and learning. It houses tables and chairs for candidates. Whiteboards and computer smartboard technology are available. Candidates will have access to the technical and library resources of both Campbellsville University and Taylor County Schools. The school principal program consists of eight face-to-face courses over two academic years with six hours of online

coursework during the summer at the midpoint of the program. This program would be available for both traditional and alternative route candidates. The coursework, assessments and clinical experiences, as well as the admission and exit criteria, will be the same as the campus-based school principal preparation program. The provost at Campbellsville University reports that the program has sufficient faculty and resources to offer this program at CKCC.

***Budget Impact:*** There is no budgetary impact.

### **Consent Item:**

Campbellsville University Program Approval: School Superintendent

### **Staff Recommendation:**

The Education Professional Standards Board (EPSB) should approve Campbellsville University's School Superintendent programs as recommended by the Program Review Committee.

### **Rationale:**

The submitted Campbellsville University programs have demonstrated compliance with the EPSB regulations for admission and standards alignment requirements established in 16 KAR 3:090. The proposed educator preparation programs follow the appropriate regulations (16 KAR 5:010; 16 KAR 3:090) outlining program requirements for program approval as established by the EPSB. The programs have completed three stages of review and received a recommendation for approval from the Program Review Committee.

### **Action Question:**

Should the EPSB approve the School Superintendent programs submitted by Campbellsville University?

### **Applicable Statutes and Regulation:**

KRS 161.028, KRS 161.030, 16 KAR 5:010, 16 KAR 3:090

### **History/Background:**

*Existing Policy:* KRS 161.028 and KRS 161.030 require the EPSB to establish curricula for educator preparation programs in Kentucky and approve such programs for Educator Preparation Providers. The Educator Preparation Branch, the Content Area Program Review Committee, and the Program Review Committee evaluated the program review documents submitted for approval against performance-based program certification guidelines established by the EPSB.

*Summary:* The submitted programs are for Certification Only, Rank I Master's, and Specialist, Traditional and Alternative routes. The proposed School Superintendent programs at Campbellsville University provide a blend of content mastery and practical experience. The programs are delivered online to permit flexibility for the working educators.

The Quality Assurance Plan (QAP) for the Superintendent programs for the candidate and the program utilizes multiple measures that monitor program candidate progress and provider effectiveness. The QAP is comprised of Candidate Assessment Points (CAPs) that mirror other educator preparation provider advanced programs and are data collection points for monitoring candidate progress in the program. There are three CAPs where candidates in the program are assessed (CAP 5, 6 and 7). These occur at major points in the candidate's preparation program. CAP 5 is admission to the program which requires Superintendent candidates to complete an

application for admission to the Campbellsville University graduate program and meet entrance requirements that includes a valid teaching certificate; official transcripts, minimum 3.0 GPA; master's degree from an accredited institution of higher education; dispositional self-assessment; two years of experience as a school/district administrator; three letters of recommendation-one from building or district level administrator, two from P-12 educators; signed Code of Ethics/Character and Fitness; Leadership Portfolio; and, a signed Superintendent's Statement. Candidates must also complete a criminal background check (if not currently teaching) and complete a diversity survey. For those completing the alternative route, a CA-TP is required as well. CAP 6 is a midpoint check in the program. It requires the completion of six hours of coursework and a 3.0 GPA. Also, one faculty dispositional assessment is required at midpoint. CAP 7 is program completion/exit that requires the candidate to complete an application form with appropriate supporting documentation. For program completion/exit, candidates must have a minimum 3.0 GPA, pass the Praxis School Leaders Licensure Assessment (if not passed as part of a previous program) and complete the Superintendent Field Project. In addition, a completed CA-1 Application must be submitted to the certification office.

Throughout their coursework and CAP criteria, candidate knowledge, skills, and dispositions are evaluated through a wide variety of assessments including traditional and nontraditional performance-based measures including exams, research papers, electronic presentations, projects, and field experiences. One of the goals of the QAP for the Superintendent programs is to continuously improve the preparation process. Program accountability occurs through multiple venues. Disaggregated data and aggregated data on candidate performance serve as accountability measures providing considerable longitudinal feedback regarding assessment of the program. Performance data from external sources (e.g. Praxis Licensure Exams) are used to assess overall program effectiveness and to address identified weaknesses. The Rank I Master's and Specialist programs will include additional admissions and exit requirements as degree and additional certifications warrant.

OELE staff, Content Review Committee specialists, and the Program Review Committee have reviewed these program proposals and determined that the programs meet the requirements for approval. Request to Approve Remote Student Teaching Observations for all Educator Preparation Programs for the Fall 2020 and Spring 2021 Semesters

#### **Staff's Recommendation:**

The Education Professional Standards Board (EPSB) should approve all student teaching observations to be performed remotely for all educator preparation programs for the Fall 2020 and Spring 2021 semesters.

#### **Rationale:**

Due to the COVID-19 health crisis, university supervisors are unable to complete in-person observations of student teachers. 16 KAR 5:040, Section 4(1) allows a portion of the observations to be remote but requires EPSB approval for remote observations. Approving remote observations will provide additional flexibility for meeting the required number of observations.

#### **Action Question:**

Should the EPSB approve all student teaching observations to be performed remotely for all educator preparation programs for the Fall 2020 and Spring 2021 semesters?

#### **Applicable Statute or Regulation:**

KRS 161.028, 16 KAR 5:040

#### **History/Background:**

*Existing Policy:* 16 KAR 5:040, Section 4(1) provides “The university supervisor shall conduct a minimum of four (4) observations of the student teacher in the actual teaching situation, a portion of which may be remote. Requests for remote observation(s) shall be submitted to and approved by EPSB prior to the observation(s).”

*Summary:* Due to the COVID-19 health crisis, university supervisors are considered visitors in school buildings. Schools have been asked to restrict the number of visitors on any given day during the Fall 2020 and Spring 2021 semesters. Further, due to potential intermittent school closures during the Fall 2020 and Spring 2021 semesters, we anticipate a portion of the remote observations will occur in online classrooms (e.g., non-traditional instruction).

In order to limit the number of visitors in a building and as a way to help maintain the best-case health scenario for university supervisors, student teachers and their classrooms, the Kentucky Association of Colleges of Teacher Education on behalf of all Kentucky educator preparation providers request permission to conduct remote observations for all four required observations for each of the Fall 2020 and Spring 2021 semesters.

16 KAR 5:040, Section 4(1) allows a portion of the observations to be conducted remotely, but requires EPSB approval for remote observations. Approving remote observations will provide

additional flexibility for meeting the required number of observations while protecting the safety of the students and teachers in the schools.

Therefore, staff is recommending that the EPSB approve all student teaching observations to be performed remotely for all educator preparation programs for the Fall 2020 and Spring 2021 semesters.

*Existing Policy:* KRS 161.100 creates an emergency certificate that can be used when a district is unable to secure a qualified teacher for a position. The certificate is valid only for the specific job for which issued and for the current school term. 16 KAR 2:120 only allows issuance of a subsequent emergency certification if the first emergency certificate was issued after February 15<sup>th</sup> of a school year or if it was issued for less than fifty (50) percent of the person's class schedule. The EPSB has previously approved waivers of this limitation on a case by case basis.

*Summary:* As the response to the COVID-19 health crisis changes so do the guidelines for schools for the 2020-2021 school year. The exceptional circumstances of this pandemic have led to requests from school and district leaders for additional flexibility for staffing and assignment of teachers for the 2020-2021 school year. The proposed waiver would allow for second issuance of emergency certification for the upcoming school year.

If a class contains fourth and fifth grade, a middle school certified teacher is able to teach his/her content to that class. The EPSB has previously approved waivers to allow middle school certified teachers to teach fourth grade in the teacher's content area on a case by case basis.

**Summary:** As the response to the COVID-19 health crisis changes so do the guidelines for schools for the 2020-2021 school year. The exceptional circumstances of this pandemic have led to requests from school and district leaders for additional flexibility for staffing and assignment of teachers for the 2020-2021 school year. The proposed waiver would allow for those educators with a middle school certificate valid for teaching fifth grade through ninth grade to also teach fourth grade in the teacher's content area(s). This waiver would only apply to the 2020-2021 school year.

Lindsey Wilson College has submitted a waiver request and a letter of support from their administration. Due to the urgency of this matter, the EPSB's procedures for conditional waiver were followed. The request was reviewed and approved by the EPSB Chair and Waiver Committee Chair, and a conditional waiver was issued. The request is now before the full board for final action.

#### **Action Question:**

Should the Education Professional Standards Board (EPSB) approve Western Kentucky University's (WKU) request to waive the grade point average requirement for an applicant's admission to WKU's Option 6 program for Secondary Mathematics certification?

#### **Applicable Statute or Regulation:**

KRS 161.020, 161.028, 161.048, 16 KAR 5:020, 16 KAR 9:080

#### **History/Background:**

***Existing Policy:*** 16 KAR 5:020 establishes the standards for admission to an educator preparation program for certification. Section 1 outlines the criteria for admission to initial and advanced teacher preparation programs. In addition to the requirements for undergraduate initial certification programs, it identifies requirements for a graduate level initial certification program. These requirements include a bachelor's degree or advanced degree from a regionally accredited college or university with a cumulative grade point average of 2.75 on a 4.0 scale or a 3.0 on a 4.0 scale on the last thirty hours; successful completion of either the Praxis Core Academic Skills for Educators exams or the Graduate Record Exam; evidence of candidate's critical thinking, communication, creativity and collaboration skills; evidence of candidate's understanding of the professional dispositions expected of professional educators; and a review of the Professional Code of Ethics for Kentucky School Certified Personnel.

***Summary:*** In collaboration with LaRue County Schools, WKU is requesting a waiver of the GPA admission requirements for an applicant. LaRue County Schools is interested in hiring the applicant as a high school math teacher. The applicant has a Bachelor of Science degree in Mathematics. WKU wishes to admit him to the Option 6 program for Secondary Mathematics Grades 8-12 certification; however, the applicant's current GPA is 2.62 and his last thirty hours is 2.82 and does not meet the admission regulation requirement. WKU has indicated that the waiver request comes from the desire to assist the district to address the teacher shortage in mathematics. Both WKU and LaRue County Schools have expressed their intent to provide support for the prospective candidate during his first year of teaching as well as throughout the program. Included in the request are letters and emails of support from the Dean of the WKU College of Education and Behavioral Sciences and the Assistant Superintendent of the LaRue County Schools as well as the high school principal.

Should the Education Professional Standards Board (EPSB) approve the applicant's request to allow the expired passing assessment scores to qualify for issuance of a certificate?

KRS 161.028, 16 KAR 6:010

#### **History/Background:**

**Existing Policy:** 16 KAR 6:010, Section 4 states "A passing score on an assessment established at the time of administration shall be valid for the purpose of applying for certification for five (5) years from the assessment administration date." The regulation further provides that an educator who fails to complete the EPSB application for certification within the applicable recency period of the assessment shall retake the assessment.

**Summary:** Lori Gausepohl Wall started working towards admission to Thomas More University's Proficiency Evaluation program for K-12 Spanish in May 2019. She completed all requirements of the program with the exception of the Praxis Core Academic Skills for Educators (CASE) reading and writing assessments. She scheduled the assessments for April 9, 2020, and then had to reschedule for May 20, 2020. Both dates were canceled because of testing center closures due to COVID-19. Ms. Gausepohl Wall would have had all certification requirements completed prior to the end of May 2020, if not for the pandemic. She has now taken and passed both of the CASE assessments through the Education Testing Service "Praxis at Home"; however, her Principles of Learning and Teaching (PLT) and Spanish content assessment scores have expired. Ms. Gausepohl Wall obtained a passing score on the PLT assessment on May 21, 2015, which expired May 21, 2020, and obtained a passing score on the Spanish content assessment on July 30, 2015, which expired July 30, 2020. She is asking that the EPSB to issue her the Spanish certification with the expired assessment scores.

16 KAR 4:090. Request to Waive Reissuance Requirements for Patsy McCoy

#### **Action Question:**

Should the Education Professional Standards Board (EPSB) approve the applicant's request to waive the six hours of graduate credit required for reissuance of a lapsed certificate?

#### **Applicable Statute or Regulation:**

KRS 161.028, 16 KAR 4:090

#### **History/Background:**

**Existing Policy:** 16 KAR 4:090, requires that an educator whose certificate lapses shall have the certificate reissued after completing six semester hours of graduate credit.

**Summary:** Patsy McCoy held a Kentucky Provisional High School Certificate for teaching Biology and Chemistry in Grades 7-12 from 1989-2008, and a Professional Certificate for Middle Grades Science, Grades 5-9 from 2004-2009. Ms. McCoy's Kentucky certification lapsed in 2009, and she has not completed the six hours of graduate credit required for reissuance. Ms. McCoy states that she spent two years as a high school science teacher, ten years as a principal and teacher at a private school, and taught science at the elementary and middle school level in Kentucky before teaching in West Virginia. She states that she taught science at the high school level in West Virginia for eight years before retiring in 2017. Ms. McCoy states that during her retirement she has continued to substitute teach in West Virginia and Kentucky. She has provided a copy of her West Virginia Professional Teaching Certificate for Biological Science, Grades 5-12 which is valid until June 30, 2021. Ms. McCoy has also held Kentucky Emergency Substitute Certification for the 2017-2018, 2018-2019 and 2019-2020 school years. The principal of Phelps High School in Pike County submitted a letter of support for Ms. McCoy's request and detailed three vacant science positions in the district and the difficulty in obtaining certified science teachers. Ms. McCoy asks the EPSB to waive the six hours of graduate credit and reissue her Kentucky certificate.
