### **Decision**

Accept Agreed Order stating:

- a. Upon acceptance of this agreement by the Board, Certificate Number 201137007 is suspended from July 1st, 2023 to December 31st, 2023. Atchley shall not be actively employed in a certified employment during the suspension period. Pursuant to KRS 161.020(1)(a): No person shall be eligible to hold the position of superintendent, principal, teacher, supervisor, director of pupil personnel, or other public-school position for which certificates may be issued, or receive salary for services rendered in the position, unless he or she holds a certificate of legal qualifications for the position, issued by the Education Professional Standards Board. Atchley acknowledges it is her/his responsibility to consult with her/his employer to determine any consequences to salary or employment benefits as a result of this Agreed Order.
- b. The Board reprimands Atchley for making comments that could cause disparagement or trauma to students. The school environment must be welcoming to all who come to learn. Making statements that potentially denigrate students or their communities based on demographic characteristics like race, national origin, religion, sexual orientation, or gender identity harms that atmosphere, and interferes with students' ability to learn in a safe, welcome environment. In addition, Atchley is hereby reprimanded for neglect of duty. An educator has a duty to take reasonable measures to protect the health, safety, and emotional well-being of students. When an educator fails to teach the curriculum in his classroom.

students are at risk of falling behind on the content they need to be successful in subsequent courses and their life beyond school. Each educator has the responsibility to seek professional development in classroom management and to stay current on proper discipline and pedagogy methods. Students cannot learn in a disorderly environment and will not respect an educator who fails to appropriately manage the classroom. The Board warns Atchley to exercise better discretion in the future and will tolerate no further misconduct by Atchley.

- c. On or before December 31st, 2024, Atchley shall submit written proof to the Board that s/he has completed the following Board-approved professional development trainings or courses:
  - 1) Any training under the heading of "Educator Ethics" on the attached pre-approved Board training list (Attachment A).
  - 2) Any training under the heading of "Appropriate Boundaries" on the attached pre-approved Board training list (Attachment A).
  - 3) The specific training by the Kentucky Professional Learning Board entitled "Classroom Management for Positive Behaviors" on the attached pre-approved Board training list (Attachment A).
  - 4) Any one (1) other training under the heading of "Classroom Management" on the attached preapproved Board training list (Attachment A).
  - 5) The specific Micro-Credential "Cooperating Teachers: Listening and Nonverbal Communication" on the attached pre-approved Board training list (Attachment A).

Any cost for said trainings shall be paid for by Atchley. Failure to submit written proof of completion on or before the deadline will result in Certificate Number 201137007 being administratively suspended until such time as the Board receives the written proof of completion.

d. Beginning on December 31st, 2023, Certificate Number 201137007 or any new certificate issued to Atchley shall be subject to the following conditions for a period of two (2) years:

1) Atchley shall have no further disciplinary action from any school district in the Commonwealth of Kentucky. If Atchley fails to satisfy this condition, Certificate Number 201137007 shall be administratively suspended pending Board review and disposition.

"Disciplinary action" is defined as any termination, suspension, or public reprimand issued by any school district in the Commonwealth of Kentucky and upheld, if requested, by either a tribunal and/or arbitration process including any appeal therefrom.

e. Atchley is aware that should s/he violate KRS 161.120 at any time, the Board shall initiate new disciplinary action and seek additional sanctions.

# **Staff Recommendation:**

The Education Professional Standards Board (EPSB) should approve the application.

# **Rationale:**

Harrison County Schools and University of the Cumberlands have submitted an Option 9 application that meets the requirements of KRS 161.048 and 16 KAR 9:110. University of the Cumberlands holds accreditation from the Council for the Accreditation of Educator Preparation and their educator preparation programs have been approved by the EPSB.

# **Applicable Statute or Regulation:**

KRS 161.028, KRS 161.048, 16 KAR 9:110

# **History/Background:**

Existing Policy: KRS 161.048(10) establishes the Option 9 alternative route to certification. This route provides for the expedited certification of a person to teach at any grade level through a cooperative program between a college or university and a school district. The expedited certification program will result in a bachelor's degree and initial certification within three school years. The candidate is not certified while completing the route but shall complete a residency/paraprofessional component and receive coaching and mentoring from experienced teachers. 16 KAR 9:110 establishes the standards and procedures for Option 9 and contains sections covering providers, residency, field experience, student teaching, application review, continuance of program approval, revocation for cause, reconsideration, data reports, and professional certificates.

**Summary:** Harrison County Schools has partnered with the University of the Cumberlands to develop a proposed Option 9 program. In accordance with Section 5 of the regulation, staff has reviewed the application and found that it meets the requirements of KRS 161.048 and 16 KAR 9:110. A copy of the application is included in the Board Meeting Materials tab for EPSB review. As part of the proposal, each party has agreed to take on the following:

Harrison County Schools will:

- Employ the participant in a residency or paraprofessional program within the school district for the duration of the program as long as the participant is making successful progress in the Option 9 program.
- Utilize experienced teachers employed by the district to provide coaching and mentoring to the participant.
- Ensure at least one mentor is certified in the area in which certification is being sought.

- Require mentor teachers to submit evaluations to the university for each candidate each semester.
- Ensure the availability of funding for each participant for the duration of the candidate's participation in the program as long as the participant is making successful progress in the Option 9 program.
- Ensure candidates have a variety of experiences.
- Ensure at least one-year of employment provides hands-on experience in the area in which certification is being sought.
- Continue this partnership until the district's employed participants for Option 9 certification complete the program or are no longer employed by the district.
- No longer accept new candidates to the program if the district decides to end the partnership.

# University of the Cumberlands will:

- Ensure that the completion of coursework and field experience will result in a bachelor's degree and initial certification.
- Ensure that courses are sequenced and offered to allow for a three-year program completion.
- Ensure that candidates document 200 hours of field experience and the eight categories of field experiences through electronic records.
- Ensure that all educator program admissions regulations are followed and documented.
- Accept work experience in place of student teaching; and
- Assign a university supervisor to work with the participant during the third year of the program.

In accordance with 16 KAR 9:110, Section 5, initial program approval will be for a period of three years. After that time, the providers may apply for continuing program approval and provide evidence of program quality.

**Budget Impact:** There will be costs associated with the oversight of this route.

Paducah Independent Schools and Campbellsville University have submitted an Option 9 application that meets the requirements of KRS 161.048 and 16 KAR 9:110. Campbellsville University holds accreditation from the Council for the Accreditation of Educator Preparation and their educator preparation programs have been approved by the EPSB.

# **Applicable Statute or Regulation:**

KRS 161.028, KRS 161.048, 16 KAR 9:110

# **History/Background:**

Existing Policy: KRS 161.048(10) establishes the Option 9 alternative route to certification. This route provides for the expedited certification of a person to teach at any grade level through a cooperative program between a college or university and a school district. The expedited certification program will result in a bachelor's degree and initial certification within three school years. The candidate is not certified while completing the route but shall complete a residency/paraprofessional component and receive coaching and mentoring from experienced teachers. 16 KAR 9:110 establishes the standards and procedures for Option 9 and contains sections covering providers, residency, field experience, student teaching, application review, continuance of program approval, revocation for cause, reconsideration, data reports, and professional certificates.

**Summary:** Paducah Independent Schools has partnered with Campbellsville University to develop a proposed Option 9 program. In accordance with Section 5 of the regulation, staff has reviewed the application and found that it meets the requirements of KRS 161.048 and 16 KAR 9:110. A copy of the application is included in the Board Meeting Materials tab for EPSB review. As part of the proposal, each party has agreed to take on the following:

Paducah Independent Schools will:

- Offer the Option 9 programs exclusively to classified employees who work in the district.
- Ensure candidates complete the same 200 field experience hours that traditional candidates complete within the first two years of residency.
- Maintain electronic records of field experiences that confirm that all residents have fulfilled the field experience requirements and share these records with the Campbellsville University School of Education.

- Require admitted candidates to sign the Professional Code of Ethics and act in an ethical manner.
- Provide training on the Professional Code of Ethics.
- Employ candidates either part time or full time for three years in a classified position.
- Employ the candidate full time in the area of certification sought during the third year of residency.
- Ensure a Paducah Independent Schools cooperative teacher and Campbellsville University supervisor will follow the EPSB approved Campbellsville University protocols for observing and evaluating student teachers including a minimum of four observations.
- Maintain electronic records that confirm that all third-year residents meet the student teaching requirements and share them with the Campbellsville University School of Education.
- Continue the partnership until the candidates currently in the program complete the program or are no longer employed by Paducah Independent Schools.

# Campbellsville University will:

- Ensure that candidates complete the EPSB approved LBD, IECE, or P-5 Elementary Education Program for Campbellsville University. Candidates who successfully complete the program and pass the licensure exams will earn a bachelor's degree and certification.
- Offer all 120 credit hours of coursework online.
- Require candidates to complete the same 200 field experience hours that traditional candidates complete within the first two years of residency.
- Require Admitted candidates to sign the Professional Code of Ethics
- Provide candidates training on the Professional Code of Ethics.
- Ensure that during the year-long residency, a Paducah Independent Schools cooperative teacher and Campbellsville University supervisor will follow the EPSB approved Campbellsville University protocols for observing and evaluating student teachers including a minimum of four observations.
- Ensure that the program does not negatively impact the accreditation of the Campbellsville University School of Education.

In accordance with 16 KAR 9:110, Section 5, initial program approval will be for a period of three years. After that time, the providers may apply for continuing program approval and provide evidence of program quality.

The traditional means of recognizing competency and proficiency for educator preparation is by earning academic credits. 16 KAR 5:030 provides an alternate means for recognizing competency and proficiency other than academic credit. This regulation outlines the criteria for an educator preparation provider (EPP) to submit a plan for EPSB approval that sets forth the process by which the EPP will conduct proficiency evaluations. The regulation became effective in August 2018. The Guidelines for Approval of Proficiency Evaluation Plans were presented to the EPSB during its December 2018 meeting. In June of 2019, Georgetown College received proficiency approval for Advanced Certification Only programs in: Art, Biological Science, Chemistry, English, French, German, Health, Instrumental Music, Learning and Behavior Disorders, Mathematics, Middle School English, Middle School Mathematics, Middle School Science, Middle School Social Studies, Moderate and Severe Disabilities, Physical Education, Physics, Social Studies, Spanish and Vocal Music. In October of 2022 Georgetown College received proficiency approval for Initial Graduate Certification programs for: Elementary Education, Grades P-5; Middle School English Mathematics, Science, and Social Studies; High School Biology, Chemistry, English, Mathematics, Physics, and Social Studies; and, Grades P-12 Art, French, German, Instrumental Music, Learning and Behavior Disorders, Moderate and Severe Disabilities, Spanish, and Vocal Music (Initial Certification)

**Summary:** Georgetown College is requesting approval for its proficiency evaluation plan for the advanced certification program, Elementary Education. The submitted proficiency adequately addresses the components of the application which includes:

- 1. Identification of the programs for which it intends to have proficiency as a pathway to certification.
- 2. Description of the process to evaluate a candidate's proficiency, who is involved in the process, and the process used to measure the applicable performance-based standards.
- 3. Description how candidates will demonstrate meeting the admission criteria of 16 KAR 5:020 as applicable.
- 4. Identification of the requirements candidates must demonstrate before being exited from the program. A description of how the exit requirements will be demonstrated is included as well as the process by which the EPP will report candidates in the EPSB Admission/Exit System.
- 5. Inclusion of a Sample Employment Eligibility letter.

The Educator Preparation Branch and the Program Review Committee evaluated the program review documents submitted for approval against performance-based program certification guidelines established by the EPSB. The program proposal meets all the requirements set forth by the EPSB.

Summary: The University of Kentucky is requesting to add the Master of Arts in Teaching, Learning and Behavior Disorders Initial Graduate and Advanced Master's Rank 1 and Rank 2 degree programs in order to address the shortage of teachers for students with Learning and Behavior Disorders. The University currently has one option for obtaining a master's degree in special education. The special education teacher leader master's degree results in graduates earning a Master of Science degree with a teacher leader endorsement. Candidates select from three tracks of specialization: moderate and severe disabilities (MSD), learning and behavior disorders (LBD), and assistive technology. None of these track's result in a recommendation for teacher certification. Rather, most commonly at the University of Kentucky, practicing teachers enroll in the teacher leader master's program to obtain advanced training and receive a recommendation for a rank change. The current master's program has restricted criteria for admission. That is, candidates who are admitted are required to hold an undergraduate degree or certification in MSD or LBD. These criteria for admission limit the type of individuals who can be admitted into the

program and thereby limit the numbers of teachers who are certified to teach. In addition, it only allows the university to prepare existing teachers as master level teacher leaders but does not provide for training new teachers obtaining their initial certification. Given the current shortage of special educators in Kentucky, it is important to have additional options for individuals to obtain master's degrees that will lead to advanced preparation and rank changes as well as those that will provide initial certifications in special education at the graduate level. The new Master of Arts in Teaching program will increase the university's ability to serve the needs of individuals seeking a special education master's and initial teacher certification and increase the pool of certified special education teachers.

# **Information Item:**

16 KAR 5:040, Admission, Placement, and Supervision in Student Teaching, Amendment

# **Rationale:**

The proposed amendment incorporates waivers that the EPSB has previously approved to allow student teachers to serve as emergency certified substitute teachers, allow student teachers to maintain classified employment, and allow remote observations of student teachers without submitting a request. The proposed amendment also incorporates some feedback received from the Kentucky Association of Colleges of Teacher Education (KACTE).

# **Applicable Statute or Regulation:**

KRS 161.010, KRS 161.028, KRS 161.042, KRS 161.102, 16 KAR 5:040

#### **History/Background:**

Existing Policy: KRS 161.010(6) defines student teacher as "an adult who has completed the prerequisite teacher preparation as prescribed by the accredited teacher education institution in which he or she is enrolled, and who is jointly assigned by the institution and a local school district to engage in a period of practice teaching under the direction and supervision of the administrative and teaching staff of the school district and the institution." KRS 161.042 further sets out the role of the student teacher but tasks the EPSB with promulgating administrative regulations on the specifics of the utilization of student teachers and the requirements for the supervising teacher, school and school district. Through 16 KAR 5:040, the EPSB has set forth the requirements for admission, placement and supervision in student teaching.

**Summary:** At the February meeting, the EPSB reviewed the proposed changes to 16 KAR 5:040 and discussed recommendations from KACTE around the number of student teaching placements and years of experience for cooperating teachers. The EPSB directed staff to make additional changes to allow student teachers to complete one placement and allow for cooperating teachers to have less than three years of experience. The updated amendment is included for EPSB review.

During the legislative session, we have also seen movement on House Bill 162. This bill has passed both chambers but is currently awaiting concurrence in the House. If it becomes law, the bill will place some additional requirements around student teaching. Specifically, Section 7 of the bill provides:

- (3)(b): Develop an evaluation rubric for observing teacher candidates with focus on mathematics content and pedagogical knowledge.

At the meeting, staff would like to engage the EPSB in discussion around these two items to determine the EPSB's desire going forward.

# **Staff Recommendation:**

The Education Professional Standards Board (EPSB) should approve the amendment to 16 KAR 2:110.

#### **Rationale:**

The proposed amendment is necessary to ensure that 16 KAR 2:110 remains in effect. The amendment also updates the regulation to remove the reference to an outdated application form and an offer of employment.

# **Action Question:**

Should the EPSB approve the amendment to 16 KAR 2:110?

# **Applicable Statute or Regulation:**

KRS 13A.3102, KRS 13A.3104, KRS 161.028, KRS 161.030, KRS 161.052, 16 KAR 2:110

## **History/Background:**

Existing Policy: KRS 13A.3102(2) provides that "An ordinary administrative regulation with a last effective date before March 1, 2013, shall expire on March 1, 2020, except as provided by the certification process in KRS 13A.3104." KRS 13A.3104 sets forth the certification process that an agency must follow to avoid the expiration of an administrative regulation. This process requires the agency to review the administrative regulation in its entirety for compliance with current law governing the subject matter of the administrative regulation and file a letter with the regulations compiler prior to the expiration date, stating whether the administrative regulation shall be amended or remain in effect without amendment. If the certification letter states that the administrative regulation will be amended, the Education Professional Standards Board (EPSB) must file an amendment to the administrative regulation within eighteen (18) months of the date the certification letter was filed.

The EPSB certified 16 KAR 2:110 with the intent to amend on December 1, 2022, and must file an amendment to the regulation on or before June 1, 2024. This administrative regulation establishes a preparation-certification program for teachers for gifted education.

**Summary:** The proposed amendment to 16 KAR 2:110 removes the references to an outdated application form and the Kentucky Teacher Internship Program. It updates the grade range of the endorsement to align with the language in 16 KAR 2:010. Additionally, the amendment updates the probationary endorsement to remove the reference to an offer of employment to comply with

the requirement in Senate Bill 265 that issuance of a certificate not be dependent upon a job offer. A copy of the proposed amendment is included for EPSB review.

16 KAR 2:160. Probationary Certificate for Teachers of Exceptional Children and Interdisciplinary Early Childhood Education, Agency Amendment

## **Staff Recommendation:**

The Education Professional Standards Board (EPSB) should approve the amendments to 16 KAR 2:160.

# **Rationale:**

The proposed agency amendment to 16 KAR 2:160 would amend the regulation to include the probationary certificate for interdisciplinary early childhood education. The requirements for this certificate mirror the requirements for the probationary certificate for teachers of exceptional children. Adding the language into 16 KAR 2:160 would allow the EPSB to expire 16 KAR 2:140.

## **Action Question:**

Should the EPSB approve the proposed agency amendment to 16 KAR 2:160?

# **Applicable Statute or Regulation:**

KRS 13A.3102, KRS 13A.3104, KRS 161.028, KRS 161.030, 16 KAR 2:160

#### History/Background:

Existing Policy: KRS 13A.3102(2) provides that "An ordinary administrative regulation with a last effective date before March 1, 2013, shall expire on March 1, 2020, except as provided by the certification process in KRS 13A.3104." KRS 13A.3104 sets forth the certification process that an agency must follow to avoid the expiration of an administrative regulation. This process requires the agency to review the administrative regulation in its entirety for compliance with current law governing the subject matter of the administrative regulation and file a letter with the regulations compiler prior to the expiration date, stating whether the administrative regulation shall be amended or remain in effect without amendment. If the certification letter states that the administrative regulation will be amended, the EPSB must file an amendment to the administrative regulation within eighteen (18) months of the date the certification letter was filed.

The EPSB certified 16 KAR 2:160 and 16 KAR 2:140 with the intent to amend on December 2, 2022, and must file an amendment to the regulation on or before June 1, 2024. 16 KAR 2:160 establishes a plan for recruiting certified classroom teachers into positions for teachers of exceptional children and creates a probationary certificate for teachers of exceptional children. 16 KAR 2:140 establishes a plan for recruiting qualified individuals into positions for teachers of children ages birth to primary age.

**Summary:** At the February meeting, the EPSB approved an amendment to 16 KAR 2:160. As staff was preparing an amendment to 16 KAR 2:140, it became clear that the requirements for the two certificates mirrored each other. Therefore, staff is recommending that the EPSB approve an agency amendment to 16 KAR 2:160 that would include probationary certificates for interdisciplinary early childhood education and allow 16 KAR 2:140 to expire. A copy of the proposed amendment is included for EPSB review.

# **Staff Recommendation:**

The Education Professional Standards Board (EPSB) should approve the amendment to 16 KAR 2:170.

# **Rationale:**

The proposed amendment is necessary to ensure that 16 KAR 2:170 remains in effect. The amendment also updates the regulation to remove the reference to an outdated application form and allow for issuance of the probationary certificate upon enrollment in an approved preparation program.

## **Action Question:**

Should the EPSB approve the amendment to 16 KAR 2:170?

## **Applicable Statute or Regulation:**

KRS 13A.3102, KRS 13A.3104, KRS 161.028, KRS 161.030, 16 KAR 2:170

# **History/Background:**

Existing Policy: KRS 13A.3102(2) provides that "An ordinary administrative regulation with a last effective date before March 1, 2013, shall expire on March 1, 2020, except as provided by the certification process in KRS 13A.3104." KRS 13A.3104 sets forth the certification process that an agency must follow to avoid the expiration of an administrative regulation. This process requires the agency to review the administrative regulation in its entirety for compliance with current law governing the subject matter of the administrative regulation and file a letter with the regulations compiler prior to the expiration date, stating whether the administrative regulation shall be amended or remain in effect without amendment. If the certification letter states that the administrative regulation will be amended, the Education Professional Standards Board (EPSB) must file an amendment to the administrative regulation within eighteen (18) months of the date the certification letter was filed.

The EPSB certified 16 KAR 2:170 with the intent to amend on December 1, 2022, and must file an amendment to the regulation on or before June 1, 2024. This administrative regulation establishes the probationary certificate for middle school teachers and the requirements for issuance and renewal of this certificate.

**Summary:** The proposed amendment to 16 KAR 2:170 removes the reference to an outdated application form. It also removes the requirement that an applicant complete coursework prior to issuance of the probationary certificate allowing the certificate to be issued upon enrollment in an

approved educator preparation program for middle school teachers. This will help already certified teachers to obtain a probationary certificate sooner. The amendment removes the reference to an offer of employment to comply with the requirement in Senate Bill 265 that issuance of a certificate not be dependent upon a job offer. A copy of the proposed amendment is included for EPSB review.

Existing Policy: KRS 161.030(3) authorizes the EPSB to select assessments for all new teachers and teachers seeking initial and additional certification as well as the minimum acceptable level of achievement on those assessments. 16 KAR 6:020, Section 2(1) provides that specialty assessment scores for applicants seeking initial OCTE certification and educators seeking additional OCTE certification shall be determined by the EPSB in consultation with the Kentucky Department of Education. 16 KAR 6:020, Section 2(2) provides that the EPSB shall specify the specialty assessments and passing scores via and order of the EPSB that shall be posted to the website.

# ASSESSMENT REQUIREMENTS Occupation-based Career and Technical Education Certification

WHEREAS, KRS 161.030(3) authorizes the Education Professional Standards Board (EPSB) to select assessments for all new teachers and teachers seeking initial and additional certification as well as the minimum acceptable level of achievement those assessments; and

**WHEREAS**, 16 KAR 6:020, Section 2(1) provides that specialty assessment scores for applicants seeking initial certification and educators seeking additional certification under 16 KAR 2:020 shall be determined by the Board in consultation with the Office of Career and Technical Education (OCTE).

WHEREAS, 16 KAR 6:020, Section 2(2) provides that the EPSB shall specify the specialty assessments and passing scores for new applicants and educators seeking an additional certificate via order of the EPSB and that the order shall be posted on the EPSB website.

IT IS HEREBY ORDERED that, pursuant to the authority vested in it by KRS 161.020 and 16 KAR 6:020, Section 2(2), and after consultation with the OCTE, the EPSB hereby orders and directs that applicants seeking initial certification and educators seeking additional certification pursuant to 16 KAR 6:020 shall be required as follows:

Identified program area, corresponding assessment with corresponding minimum passing score, and allowable substitution, if applicable.

**Existing Policy:** 16 KAR 5:040, Section 5 provides that each educator preparation provider shall provide a full professional semester to include a period of student teaching for a minimum of seventy full days, or its equivalent, in instructional settings that correspond to the grade levels and content areas of the student teacher's certification program.

Summary: District closures have made it impossible for some student teachers from Transylvania University to complete the required seventy (70) full days in instructional settings before the close of the Spring 2024 academic semester. District closures are out of the control of the student teachers and the educator preparation providers; however, both have made good faith efforts to complete as many hours as possible during the Spring 2024 semester. Transylvania University has submitted a list of student teachers that were affected, as well as details of the efforts made by the institution and student teachers to reach the required number of days.
